The purpose of this letter is to apprise your office that Testa Enterprises, Inc. plans to be the managing member of a residential rental development located in or within a one-half mile radius of your political jurisdiction, and will submit an application to utilize the multifamily funding programs of the Ohio Housing Finance Agency (OHFA) for the development of this property.

Testa Enterprises, Inc. is proposing the development of Residences at Ascend, a 71-unit modern affordable apartment community in downtown Akron. The development will be part Testa's Ascend Akron development which will redevelop the former Akron City Centre Hotel, (originally constructed as a Holiday Inn in 1971) into a mixed-use, mixed income building. The Residences at Ascend will provide 71 one-, two-, and three-bedroom affordable apartments on floors 4-11 of the 19-story building. The remaining portions of the building will be developed into market rate apartments, community amenities and future commercial space.

The proposed development will be financed with residential rental private activity bonds, Housing Credit proceeds, an FHA first mortgage, Housing Development Loan, and other grant sources.
