Greetings Rev Harrison,

As leaders within the district, we are held to a higher standard of ethical conduct. We all have a responsibility to report any instance of unethical behavior, including potential breaches of confidentiality or misuse of confidential information by an APS employee or board member.

You have recently expressed disapproval to others regarding my decision to report potential ethical concerns re: an APS board member to Attorney Diana Feitl, APS board legal advisor and board president Diana Autry. I understand you challenged my decision to report an ethics violation directly to Attorney Feitl and Ms. Autry, and advised my supervisor that I instead 'stay in my place'.

Threatening or discouraging staff members (directly or indirectly) from reporting potential wrongdoing by a board member is unacceptable. Such actions can have serious consequences, including legal ramifications if left unchecked.

It's important to note that you do not have the authority to restrict my professional communication with anyone, including colleagues or board members. I urge you to reconsider your approach to addressing concerns related to me, and to refrain from a posture of bullying. I am committed to working together to maintain a positive and productive working environment that is worthy of emulation by our scholars, teachers, staff, and administrators and with a laser sharp focus on our kids.
