On 11/19/24 Ofc.Stottsberry 1653 and I, Ofc.Coblentz 1586 arrived at 1431 S. Main St. reference Felonious Assault/Domestic Violence.

Ofc.Stottsberry and I were at the listed residence the previous evening reference a fight. We made contact that evening with Robert Johnson who is the owner of the building, Charles Johnson, and the victim [REDACTED] (24-137993).

Robert and [REDACTED] are in a relationship and both live at the listed residence together.

Officers were called to the residence today (11/19/24) reference a domestic fight that was occurring on the bottom floor of the residence. When we arrived we observed the rear door to the residence cracked open and multiple dogs barking, we knocked and announced ourselves. We then made contact with Charles Johnson. Charles opened the door and told us he was going to put the dogs away and abruptly shut the door, Charles also locked the door. We then began knocking repeatedly and continued to announce ourselves advising Charles and Robert to open the door.

We continued to knock, even kick the door while continuing to announce ourselves, Robert and Charles refused to open the door. Ofc.Stottsberry and I continued to knock and kick on the door while still announcing ourselves. We made contact with Robert Johnson who exited the residence into the side patio of the building which we were separated from. We gave Robert orders to open the back door to the residence where we were standing. As we were knocking and announcing, the door suddenly opened and we observed [REDACTED] running out of the residence in a panic. [REDACTED] had multiple lacerations to her face, a swollen and bruised eye, and was actively bleeding from multiple lacerations to her face. Ofc.Locaffaro and Ofc.Chamberlain were able to put [REDACTED] in the back of uniform patrol Car 7 and called for immediate EMS.

Due to the severity of [REDACTED]'s injuries we needed to ensure there were no other victims or suspects inside the residence. We continued to knock and kick the door while giving Robert verbal commands to open the door. Robert finally opened the door and stood in the doorway refusing to move. We advised Robert to exit the residence and he refused to follow our orders.

I grabbed Robert by his left arm and felt him tense up and begin moving back into the apartment. Ofc.Stottsberry and I both grabbed Robert who continued to ignore our orders and actively resist officers. Robert continued to tense up and pull away from us. Force had to be used to remove

Robert from the doorway and he was taken to the ground by myself and Ofc.Stottsberry.

We gave Robert repeated commands to get on his stomach and put his hands behind his back.

Robert continued to ignore our lawful commands. We were able to gain control of Robert's hands and placed him in handcuffs without further incident. Robert was assessed on scene by EMS and cleared.

█████ was transported to AGMC by EMS. Ofc.Stottsberry road with █████ to AGMC.

We made contact with Charles again as he went to the rear of the residence where he began placing items in his vehicle. Charles was apprehended without further incident and placed in the back of uniform patrol Car 5 (being worked by Ofc.Kenney 1499 and Ofc.Martinez 1657).

█████ stated Robert became angry because he believes █████ was cheating on him with the maintenance man. █████ stated Robert began yelling at her and began to assault her. █████ stated Robert began repeatedly kicking her in the vaginal area and in the anal area. █████ told us Robert then obtained a pistol and began pistol whipping her in the head and face. █████ stated Robert bit her above her right eye. Officers observed multiple severe lacerations, severe swelling and bruising to █████'s face consistent with her statement.

█████ told us she has been living at the residence with Robert for around 2.5 weeks. █████ stated any time she made "too much noise" she was physically assaulted by Robert. █████ told us anytime she would go into the office to grab something to drink, Robert would enter and hold a knife and gun up to her. █████ stated anytime she would make too much noise, Robert would force her to go into the dark basement and sit in the darkness as punishment. █████ stated that Robert would assault her before forcing her into the basement. █████ stated she stayed in the dark basement because she was so fearful of Robert and his repeated assaults of her. █████ told us anytime she tried to call 9-1-1 Robert would take her phone and break it in order to prevent her from being able to get help from emergency services. █████ stated Robert would not allow her to drink or eat for days at a time. █████ stated this has all been going on for the past few weeks.

█████ told us Robert has multiple cameras throughout the residence. █████ stated the cameras are all connected to his office in the house. █████ stated there is a safe in the office where Robert keeps his firearm. Officers were unable to enter the office due to the presence of multiple large

dogs. [REDACTED] stated she believes Robert has an app on his phone where the cameras are also connected.

We made contact with Robert Anderson who was the initial caller. Anderson told us he lives above the bottom living area where Robert Johnson and [REDACTED] live. Anderson stated he heard Robert screaming at [REDACTED] and heard Robert hitting [REDACTED]. Anderson stated he heard Robert attempting to have his dogs attack [REDACTED]. Anderson stated he heard [REDACTED] screaming for help and crying. Anderson told us he heard Robert yelling at his dogs to "sick her".

AGMC confirmed [REDACTED] suffered multiple broken bones in her face. [REDACTED] required multiple stitches. Unknown of any further injuries or diagnoses at this time as more imaging and care was required.

Robert and Charles were transported to SCJ by Wagon 86.

PLA Volcheck approved charges.

SGT on scene and DB notified.
