

Robert from the doorway and he was taken to the ground by myself and Ofc.Stottsberry.
We gave Robert repeated commands to get on his stomach and put his hands behind his back.
Robert continued to ignore our lawful commands. We were able to gain control of Robert's hands and placed him in handcuffs without further incident. Robert was assessed on scene by EMS and cleared.
was transported to AGMC by EMS. Ofc.Stottsberry road with to AGMC.
We made contact with Charles again as he went to the rear of the residence where he began placing items in his vehicle. Charles was apprehended without further incident and placed in the back of uniform patrol Car 5 (being worked by Ofc.Kenney 1499 and Ofc.Martinez 1657).
stated Robert became angry because he believes was cheating on him with the maintenance man. stated Robert began yelling at her and began to assault her. stated Robert began repeatedly kicking her in the vaginal area and in the anal area. told us Robert then obtained a pistol and began pistol whipping her in the head and face. stated Robert bit her above her right eye. Officers observed multiple severe lacerations, severe swelling and bruising to stated consistent with her statement.
told us she has been living at the residence with Robert for around 2.5 weeks. stated any time she made "too much noise" she was physically assaulted by Robert. told us anytime she would go into the office to grab something to drink, Robert would enter and hold a knife and gun up to her. stated anytime she would make too much noise, Robert would force her to go into the dark basement and sit in the darkness as punishment. stated that Robert would assault her before forcing her into the basement. stated she stayed in the dark basement because she was so fearful of Robert and his repeated assaults of her. told us anytime she tried to call 9-1-1 Robert would take her phone and break it in order to prevent her from being able to get help from emergency services. stated Robert would not allow her to drink or eat for days at a time. stated this has all been going on for the past few weeks.
told us Robert has multiple cameras throughout the residence. stated the cameras are all connected to his office in the house. stated there is a safe in the office where Robert keeps his firearm. Officers were unable to enter the office due to the presence of multiple large
